

KINLET PARISH COUNCIL.

**MINUTES OF THE MEETING HELD ON MONDAY,
14th OCTOBER 2019 IN THE PARISH HALL
COMMENCING AT 7.30 p.m.**

0. PUBLIC PARTICIPATION. One Parishioner was in attendance when a discussion took place re the proposed provision of a defibrillator at the Button Oak Public House and the possibility of a donation from the Parish Council which had already been agreed in principle.

1. APOLOGIES were received from Mr. S. Harris (business commitments – acceptable reason). Also Mr G. Butler.

2. DECLARATIONS OF INTEREST. No interests were declared.

3. MINUTES OF THE SEPTEMBER MEETING were taken as read, amended and unanimously approved by all present at that meeting.

4. MATTERS ARISING.

1. HIGHWAY MATTERS. Once again Shropshire Council had been unable to provide any positive updates on the following matters –**a. Kinlet Edge Bank Edge Filling/Schedule of Works for Current Year/Punches Corner/Stones in Front of The Woodlands Bus Shelter/Borle Mill to Tiphouse Gully Cover Resetting/Kinlet Sewage Plant/Road Outside Worcestershire Marble/Blocked Pipe Opposite Winnal** – this was now proving a potentially dangerous situation with water over the road causing traffic to move to the centre of the road by the bend – Shropshire Council would be asked to treat this as a matter of urgency before an accident occurred.

Other Highway Matters. b. Dropped Kerb at Park Close – We had been supplied with contact details of an outside contractor who may be able to quote for the work – being progressed. **c. Re-Seeding of Verge at Button Oak** – Seed probably washed away and now a Spring matter. **d. Kingswood Lane Rubbish Collection** - meeting with owner of the land in question arranged for 2 weeks time. **e. Painting/Cleaning of White Gates at Button Oak** - Still progressing. **f. Damaged 30 mph Sign at Button Oak** – now sorted. **g. Highley Golf Club Sign on Grass Verge** – thought it had been there some time/no action.

2. ENFORCEMENT MATTERS. There were no updates to report.

3. PARISH PLAN QUESTIONNAIRE PROGRESS. – 35 Questionnaires had been completed so far and councillors were urged to chase family and friends to fill one in.

6. PLANNING APPLICATIONS.

1. 19/03832/FUL for Conversion of existing rural building to one dwelling and associated works to Barn to the North of Button Bridge Lane, Button Bridge. Whilst it was a unanimous decision to recommend approval there was concern relating to the narrow access to the property and whether vehicular right of way had been demonstrated. There was also additional concern re the upheaval construction traffic may cause to neighbours and it would be suggested that a construction management plan be requested before any approvals were given.

It was a unanimous decision to approve this budget after proposal and seconding.

8. COUNTY COUNCILLORS' REPORTS.

Mrs. Shineton advised that Airband were expanding into the area to assist broadband speeds.
