## KINLET PARISH COUNCIL.

## MINUTES OF THE ANNUAL PARISH COUNCIL MEETING HELD ON TUESDAY 9<sup>TH</sup> MAY 2023 IN THE VILLAGE HALL COMMENCING AT 7.00 P.M.

Prior to joining the meeting Mr Kirton welcomed Mr. Crawford onto the Parish Council and he signed his Declaration of Acceptance form.

- 1. **ELECTION OF CHAIRMAN.** It was proposed, seconded and unanimously approved that Mr. P. Kirton be re-elected Chairman for the forthcoming year.
- **2**. **APOLOGIES** were received from Mr. R.Oakley (illness approved reason) and Mr. G. Butler
- **3. DECLARATIONS OF INTEREST.** None were raised at this point.
- **4. ELECTION OF VICE CHAIRMAN.** It was proposed, seconded and unanimously approved that Mrs J. Rowley be re-elected as Vice Chairman.
- 5. ELECTION OF OTHER REPRESENTATIVES.
  - <u>1. Parish Hall.</u> Mr. D. Haywood and Mr. P. Horsfall were unanimously appointed to continue in these rolls and Mr. Oakley would be asked at the next meeting if he was willing to continue also.
  - <u>2.Area Committee</u>.Mr. Shepherd confirmed after the meeting that he would be willing to continue as our representative and this would be confirmed at our next meeting.
- **6. APPROVAL OF BANK RECONCILIATION AS AT 31/3/2023.** It was unanimously approved as presented after proposal and seconding
- 7. PUBLIC PARTICIPATION. There were no members of the public present.
- **8.** APPROVAL OF THE MINUTES OF THE APRIL MEETING. It was proposed, seconded and unanimously approved as presented.
- 9. MATTERS ARISING. 1a. HIGHWAY MATTERS. <u>S.C. Updates</u> re. a. White Line Renewal Kinlet Cross Roads Due to take place on the 10<sup>th</sup> May. b. Signs at Chamberlain Lodge Mr. Kirton to check that all the proposed signs had been erected.
  - **c. New Drain Installation at Button Oak** S.C. Had advised that a letter was being sent to owner re the legality of draining onto the highway. **d. Winnal Drain.** Flooding over road better but still flooding road to some extent to be chased.
  - **e. FixMyStreet Updates** It was difficult to obtain such updates and agreed this system was not 'fit for purpose.' Outstanding matters to be chased Clee House to Nortons End/Catsley Corner to Lewis Motor Subsidence/Potholes Meaton Lane/Tarmac sinking above Borle Mill and Broken Post/The potholes by Village Hall and 2 instances of Fly Tipping had been sorted.

Diamond Buses had confirmed drivers would be reminded re this matter - Mr. Oakley to be asked to keep an eye on this matter. h. Closure of A.4117 and Sturt Lane - Concerns this may cause traffic to divert into Sturt Lane - S.C. to be contacted i.Overhanging Roadside Vegetation CuttingResponses Mr. Shepherd to visit one property (date to be confirmed) and Mr Kirton to check on B4194 road - no replies from 2 properties. j. Old Farm House, Button Bridge. Flooding to be reported.

- 2. 23/01695/FUL for erection of 2 storey side extension, single storey rear extension and new porch and canopy to No.1 Meaton Lane. Erection of single storey rear extension, removal pitched roof over kitchen and create new balcony and new porch and canopy to no.2 Meaton Lane and render all elevations to both properties 1 & 2 Meaton Lane. All unanimously approved after proposal and seconding.
